### Washington Department of Natural Resources (DNR) Outdoor Access and Responsible Recreation (OARR) Plan

<u>Version 2 - Commissioner's Purpose Statement and DNR DRAFT Goals</u>

#### Commissioner of Public Lands' Purpose Statement for the OARR Plan:

"To develop a shared vision for outdoor access to and responsible recreation on DNR-managed lands, that protects Tribal rights and cultural and spiritual practices, provides diverse and high-quality recreational opportunities that foster engagement from all communities, promotes a strong sense of environmental stewardship, and enriches the quality of life in Washington. A key part of this work will be to articulate what responsible and sustainable use of DNR-managed lands for generations looks like, in order to ensure that all outdoor users are taught and practice preservation and responsible use."

#### **DNR DRAFT Goals:**

- Preserve and Protect the Natural Environment and Cultural Resources
   Address activities that impact the range and health of fish and wildlife on upland, riparian, and coastal habitats as well as cultural and spiritual sites.
- 2. Build an Outdoor Stewardship and Responsibility Ethic
  Care for these resources, promote ethical and considerate interaction with other
  recreationists and the public, and minimize conflict among users.
- 3. Increase Equitable Outdoor Access and Responsible Recreation Development, Stewardship, and Management

Recognize and address recreation challenges and needs, increase internal and external capacity, enhance support for on-the-ground stewardship activities, and stimulate external collaboration.

- 4. Secure Financial Stability for Recreation Development, Stewardship, and Management
  - Identify funding challenges, highlight the environmental and economic benefits of recreation investments, and develop recommendations for sustainable, reliable funding.
- 5. Mitigate Climate Impacts and Build Resilience
  - Prepare for extreme climate-related events, implement forward-thinking infrastructure design, and integrate management techniques that improve resilience, in alignment with DNR's Plan for Climate Resilience.
