Meeting Purpose: To update the committee on budget and all forest goals, review and discuss soils/geology and management suitability module within the planning area, and begin new committee member recreation presentations.

Welcome: Eric opened the meeting and welcomed all to introduce themselves and reviewed agenda.

General Updates:

- Grazing: Eric Winford Washington Conservation Corps (WCC) is currently building fence with a contract through the Department of Ecology, mostly on the north fork. Grazing monitoring will be occurring.
- Roads: Nick Jones Roads wintered well despite the heavy snow this winter. In the process of replacing two gates: Jungle/Rye Creek and Indian Creek.
- Fish blockage repairs: Nick Jones -- Lower Lick Creek pipe will become a bridge, as well as other
 fish barrier replacement projects, but are funding dependent. Shaded fuel break taking place on
 Cle Elum Ridge behind the Masterson property, scheduled to be completed in the next 10 days.
 Next, the shaded fuel break crew will bump to Lick Creek and should be complete by the end of
 June.
- Aquatic Restoration: Eric Winford restoration on Indian, Jungle, Middle and First Creeks will begin this summer.
- Community Involvement: Eric American Rivers and Trout Unlimited are interested in river monitoring. The agencies are working on survey protocols and local Trout Unlimited volunteers will monitor stream temperature in the streams where restoration work will be taking place.
- Paul Jewell Teanaway Valley Family Farms acquisition: the Board of County Commissioners will take up the purchase of sale agreement on the 13th. The property will be owned by WDFW at the end of June. A parking lot will be created on the east side of Teanaway Road that will accommodate approximately 20 vehicles.

Review biological suitability module - Doug McClelland, William Meyer

What makes the Teanaway so special? The Teanaway has high and low elevation, water, and is a transition zone between alpine lakes and pine/shrub steppe area. The forest is still very intact. The forest has large carnivores, many fish, wolverines, large numbers of deer and elk, and is well connected between the Cascade Crest and the Columbia River.

Biological suitability maps may change color throughout the year as animals are more mobile and plants will be surveyed on the ground as projects are planned.

Yakima Basin Integrated Plan (YBIP): The TCF is part of a plan on how to take care of the region for the next few centuries. TCF is part of the much bigger YBIP effort.
