This is to advise you that pursuant to WAC 197-11-900 (922 through 948), the Department of Natural Resources has determined that it is Lead Agency for the following:

Wright Fit Timber Sale #94515 and Forest Practice Application #3021390 is a harvest of approximately 2,127 MBF of timber on an estimated 737 acres. The proposal includes 2,675 feet of road construction, 1,761 feet of road reconstruction and 51,073 feet of road maintenance. Located in Sections 10, 15, 16, 21, 22, 28, 33 and 34, Township 34 North, Range 25 East, W.M., Okanogan County.
