SUBJECT: **SEPA LEAD AGENCY & DETERMINATION OF NONSIGNIFICANCE**

This is to advise you that pursuant to WAC 197-11-900 (922 through 948), the Department of Natural Resources has determined that it is Lead Agency for the following:

Beignet Timber Sale #105182 and Forest Practice Application #2819304 proposal is a variable retention harvest of approximately 4,562 MBF on approximately 129.3 acres. The proposal includes approximately 2,924 feet of road construction, 2,259 feet of road reconstruction, 334 feet of existing road to be abandoned after completion of use, and 47,263 feet of pre-haul maintenance. Located in Sections 13, 14, 22, 23, 24, 25, 26, 27, 35, Township 32 North, Range 06 East, and Sections 19, 30, Township 32 North, Range 07 East, W.M., Snohomish County.
