This is to advise you that pursuant to WAC 197-11-900 (922 through 948), the Department of Natural Resources has determined that it is Lead Agency for the following:

**Forest Practice Application #2614532 is an even-aged and salvage harvest of an estimated 2,104 MBF of timber on approximately 105.2 acres using shovel, full suspension, lead end suspension cable, and helicopter logging methods. The proposal includes 5,006 feet of road construction. Located in Sections 17, 20 and 21, Township 29 North, Range 11 West, Clallam County.**
