This is to advise you that pursuant to WAC 197-11-900 (922 through 948), the Department of Natural Resources has determined that it is Lead Agency for the following:

Fancy Nancy Timber Sale #94534 and Forest Practice Application #2614504 is a variable retention harvest of approximately 84 net acres with an estimated sale volume of 3,000 MBF of timber. The proposal includes approximately 300 feet of new road construction, 24,265 feet of pre-haul maintenance, additionally there will be 645 feet of road deactivation. Located in; Sections 03, 08 and 09, Township 25 North, Range 11 West, WM., Jefferson County.
