This is to advise you that pursuant to WAC 197-11-900 (922 through 948), the Department of Natural Resources has determined that it is Lead Agency for the following:

**Road Use Permit #50-094659 and Forest Practice Application #2614580 is a proposal for the construction of approximately 200 feet of new road, and use and betterment of approximately 4,559 feet of existing road, with a right-of way harvest of approximately 73 MBF of timber. Located in Section 16, Township 29 North, Range 11 West, W.M., Clallam County.**
