This is to advise you that pursuant to WAC 197-11-900 (922 through 948), the Department of Natural Resources has determined that it is Lead Agency for the following:

Echo Lake Timber Sale #93069 and Forest Practice Application #2418933 is a timber harvest of approximately 2,086 MBF on 58 net acres. The proposal includes 2,917 feet of optional construction, 585 feet of required reconstruction, 1,672 feet of abandonment, if constructed, 5,000 feet of required pre-haul and 14,285 feet of required post-haul maintenance. Located in Sections 02, 11 and 12, Township 23 North, Range 07 East, W.M., King County.
