WetSAG

Forested Wetland Effectiveness Study (FWEP)

- The draft study design will be sent to CMER for review following Nate's presentation on January 23, 2018. Comments will be due by February 23, 2018.

Westside Type F Riparian Prescription Monitoring

- The study design was approved by ISPR on January 8, 2018. The TWIG is requesting CMER approval of the document, and will discuss implementation of the project.
- The group is developing a "prospective" Findings Report for the study design which will be transmitted to policy with the study design as required by the revised LEAN process. There will be a 14 day CMER review for the document.

Unstable Slope Criteria

- TWIG members have revised the draft study design based on the CMER review. The group is requesting CMER approval to send the document to ISPR for review.
- The TWIG will discuss this month the next steps in moving forward with the remaining study designs that are to be developed.

Road Prescription-Scale Effectiveness Monitoring

• TWIG meet with ISPR reviewers to discuss revised proposal. The revised study design was submitted to ISPR and is currently under review.

<u>Eastside Type N Riparian Effectiveness - Perennial (ENREP)</u>

ISPR comments received by TWIG, the group held a conference call with ISPR reviewers and AE to discuss most recent comments. Revising the document based on that discussion with a deadline of January 18th. Anticipate ISPR approval late January or early February. Also revising and updating project budget based on revised study design. Revised budget due early February 2018.
