WHEREAS, the Department of Natural Resources proposes to transfer Common School Trust lands described in the attached EXHIBIT A and located in Jefferson County from Common School Trust status into Natural Resources Conservation Area status to be held and administered by the Department of Natural Resources under Chapter 79.71 RCW; and

WHEREAS, the transfer was approved by the Board of Natural Resources in Resolution No. 1621 on December 5, 2023, under Land Transaction File No. 02-099529 for the transfer price of \$10,095,227; and

WHEREAS, all oils, gases, coals, ores, minerals, and fossils, are reserved as referenced in Resolution No. 1620 and Inter-grant Exchange 86-100443, as provided under RCW 79.11.210, and easement rights are reserved as provided under RCW 79.36.370; and

WHEREAS, the land value of \$3,470,393 has been deposited into the Real Property Replacement Account and the timber value of \$6,624,834 has been deposited into the Common School Construction Account; it is therefore

ORDERED and DIRECTED that the property is hereby transferred to Natural Resources Conservation Area status and dedicated as such by § 3133, chapter 474, Laws of 2023, subject to the provisions of Laws of 2019, ch. 413, § 3281 and RCW 79.17.200. The property shall be retained as Permit Lands as defined in the Department of Natural Resources' Habitat Conservation Plan. This Department Order, together with Resolution No. 1621, shall be considered the official documents of said Land Transfer No. 02-099529.
