Teanaway Community Forest Advisory Committee Meeting-6/12/2014 Public Comments

Verbal Comments received during the meeting:

• Shawn Clark from East Wenatchee is a recreational user in the Teanaway. He would like to make sure that the process supports all different types of use in the forest. He wants to volunteer to do work in the forest. He saw this process and wanted to get involved in the discussion. The off road users have been using the land and want to continue using it where possible. People who do off road riding are volunteer oriented and want to help with projects in the forest. This can be a benefit for the forest.

Online/Written Comments Received:

122 public comments were received since the last advisory committee meeting primarily addressing ATV/ORV usage on the forest. One additional comment on kayaking and one on forest health were also received. Additionally a report by a CWU college student with proposed policy recommendations was received. The comments and paper follow in their entirety.

06/02/2014	I would like to see motorized recreation trails in the community forest, specifically for motorcycles. There is a large demand for this type of trail and a constantly declining amount of trails available. Off-road motorcycle clubs have a long history of participating in cooperative trail maintenance, and would likely provide much of the labor needed for maintaining the trails.
06/02/2014	Much of the TCF is surrounded by private land/farms. What used to be access is currently posted as "Closed/No trespassing"Hopefully, your team can work to open access. I have heard the term "Illegal trails" many times I have I read notes from the Advisory Committee. I feel that is not a proper term. So of these trails date back to the 1800's as access to coal mine. Some of the local senior Cle Elum generation talks of walking those trails in the 1930's and 1940' to work the hay fields in the Teanaway. Before large timber companies about the land, these trails were used for local recreation: Horseback riding, hunting, fishing, hike, motorcycles, etc. Long after most of these trails were established, Timber companies restricted access. That action does not. Most were existing trails that had their use restricted by the Landowner at that time.
06/02/2014	Thanks for the opportunity to comment on the TCF and recreational opportunities there. I am a firm believer in providing multi use opportunities for recreation on forest lands. As a

06/02/2014	hiker, I appreciate the hundreds of miles of trails available in the State and National forests, including the climax scenic vistas of our wilderness and roadless areas. As a mountain bike and motorcyclist, the opportunities for obtaining similar vistas are far less available. The Teanaway country is well-suited to motorized forest use on an appropriate seasonal basis to maintain trail stability and avoid forest fire dangers. Any plans for recreation in the TCF should include appropriate use by two and four wheeled off road vehicles. Please allow 2 wheel motorized recreation in the TCF.
06/02/2014	Please consider opening the land to motorized recreation. Our street-legal off-road motorcycles are the principal way that my family enjoys WA's forests. I regularly travel from Seattle to areas with ride-able unpaved roads, and especially those that have trail systems available. Forestry

To manage the TCF for working lands, ecosystem stability, and landowner safety.

Historically, the practices of the forestry industry have been at odds with the goals of ecosystem preservation, whether it is a fight over harvesting old-growth forests and preserving endangered species habitat, or a debate over how close to streams logging roads should be allowed. Despite this adversarial relationship, strategies to reconcile forestry and environmental integrity have been increasingly refined and implemented by Washington State, with more or less successful results. For example, preliminary results of Riparian Management Zone (RMZ) assessments—conducted by a group made up of representatives from the DNR's Forest Practices Program, the WDFW, the United States Fish and Wildlife Service, and the Washington State Department of Ecology—showed a 63% compliance rate with the Forest Practices Habitat Conservation Plan in eastern Washington, and a 91% compliance rate in western Washington (FPHCP) (FPHCP, 2005).

Developed chiefly by the Washington State Department of Natural Resources, the FPHCP was created to reconcile the Forest Practices Act of Washington State with the Federal Endangered Species Act (ESA), with the intent to, "provide long-term conservation of covered species (under the ESA), support an economically viable timber industry and create regulatory stability for landowners" (DNR, 2014). The FPHCP provides guidelines for RMZs throughout the state; the rules put forth in the FPHCP regarding bull trout habitat have been used to provide recommendations for riparian habitat in this report. Since the objectives and standards for bull trout habitat focus more on fish habitat and water quality, they are fitting for the Teanaway, and in line with the goals of the Yakima Basin Integrated Plan.

By the middle of the 20th century, most of the old-growth trees in the Teanaway watershed had been logged, and second growth timber extraction was carried out by different logging companies until the beginning of the 21st century. By the time Washington State purchased the land, there was little in the way of commercially viable timber, and there may not be for decades. Until commercial timber operations are economically viable in the forest, management should focus on maintaining the health of the forest ecosystem, and evaluate potential areas for future timber extraction. The possibility of salvaging small diameter or dead trees for bio-energy fuel stock should also be considered. If commercial timber or biomass salvage operations do take place in the TCF, all revenue generated in the form of timber or bio-mass sales should be reinvested directly into the TCF.

A working cooperation between landowners and regulating agencies is an important aspect of creating a successful forest management program. By growing a trusting and mutually advantageous relationship between agencies, such as the Kittitas County Conservation District, and landowners in the Teanaway, consistent

management can be implemented throughout the forest, increasing the chances of effective outcomes. An example of a fruitful program between land owners and government agencies in the Teanaway can be found in the community of Wagon Wheel, which became a Firewise Community in 2010, with the Wagon Wheel Fuels Reduction Project (Advisory Committee Field Trip Packet, 2014). The Fuels Reduction Program included a partnership between landowners and the KCCD to reduce over-grown under-stories, and provided a chipper for landowners to mulch slash that represented a fire hazard. Continued cooperative efforts and educational opportunities for land owners is essential to a prosperous future in the Teanaway.

Goal 1. Protect and improve water quality and forest health for aquatic and terrestrial habitat with sustainable forest management practices.

- Policy/Action 1. Designate RMZs compliant with bull trout habitat requirements
 - 75- 130 ft wide on either side of bankfull channel width (the highest discharge of a stream before flood stage) (WAC 222-30-022)
 - Require shade within 75' of bankfull stream width (FPHCP, WAC 222-30-040)
- Policy/Action 2. Implement practices to limit sediment delivery to streams from forestry activities by reducing compaction
 - No vehicles in RMZ for forestry activities, no road construction in RMZ
 - Limit road sediment per mile per year in accordance with the FPHCP (1-3 T/yr) (FPHCP, 2005)
 - Restrict mechanical timber extraction on steep slopes to minimize surface disturbance and thus limit erosion rates and increase infiltration (Page-Dumroese et al, 2006; Cram et al., 2007).
- Policy/Action 3. Enhance fish habitat leaving woody debris located in, or partly in, bankfull channel width.
- Policy/Action 4. Determine areas to be managed for future forestry, ecological succession, and/or habitat connectivity.

Goal 2. Manage insect infestations and wildfires in ways that strengthen forest health and defend private property.

- Policy/Action 1. Implement policies intended to maintain historic fire regimes of frequent, low to moderate intensity fires, with occasional stand replacement intensity (Wright and Agee, 2004; Advisory Field Trip Packet, 2014).
- Policy/Action 2. Protect and encourage large diameter trees while limiting understory growth and enhancing open space (Brown et al., 2003).
- Policy/Action 3. Evaluate the potential for an alternative exit route out of the forest for safety reasons.
- Policy/Action 4. Fuel reduction programs, without entering RMZs, similar to the Wagon Wheel Fuels
 Reduction Project of 2010 (Advisory Committee Field Trip Packet, 2014)

- 200 ft zone of landscape management and fuels reduction around structures, and some fuel reductions on slopes beyond 200 ft (National Fire Protection Association and Firewise Communities, 2014).
- Policy/Action 5. Evaluate areas where the thinning of mature trees (over 10 inches diameter or 80 years)
 may be required to control outbreak of mountain pine, (Halloin, 2003).
 - Mature stand thinning to improve resistance
- Policy/Action 6. Designate certain times of year to thin to avoid slash available for pest breeding, avoiding late winter and early spring (Halloin, 2003).
- Policy/Action 7. Evaluate whether or not dead trees should be left or removed based on the risk of spreading harmful insects or fire danger.

Goal 3. Coordinate consistent management throughout the watershed.

 Policy/Action 1. Implement educational opportunities for land holders to learn about protecting their private property, and encourage partnerships with Firewise Communities,

and Kittitas County Conservation District

- Policy/Action 2. Continue coordination between Kittitas Fire Districts, the DNR, Kittitas County
 Conservation District, and private land owners to protect private property and forest ecology
- Policy/Action 3. Evaluations and compliance monitoring of forest practices, in compliance with WAC
 222-08-160, will be the responsibility of the DNR, in consultation with the WDFW

Goal 4. Manage forests for future revenue to be reinvested in the Teanaway Community Forest.

- Policy/Action 1. Determine potential areas for future timber extraction, separate areas for extraction and areas for large diameter tree protection
- Policy/Action 2. Evaluate bio-energy feedstock potential from thinned small diameter vegetation or disease control (KCCD, 2009)
- Policy/Action 3. Maintain account to manage funds meant for the TCF
 - Teanaway account already in place (Teanaway Advisory Committee Meeting, 2014)

Evaluating Results

There are a couple of methods that can be used to evaluate the progress of programs and strategies to meet the goals outlined above, as lined out in the FPHCP: first, there is "effectiveness and validation monitoring," to verify whether or not the goals of specific programs are being met (e.g. less than 1-3 tons of sediment per road mile per year delivered to a stream from a logging road), and whether or not those goals are sufficient to fulfill the overarching objectives of the program (e.g. enhanced water quality in the stream); second, there is "intensive monitoring," which looks at the cumulative impacts of forestry programs on a watershed scale in order to study the relationships between programs and resources, with the goal of informing future management strategies (FPHCP,

2005). Evaluations should be constructed and carried out by a joint task-force of representatives from the DNR, and WDFW.

External Factors

One of the most significant impediments to the implementation of the above policies is a lack of funding. Without proper financial resources there will not be educational programs, researchers to evaluate progress toward goals, workers to perform maintenance activities, or enforcement personnel, compromising the effectiveness of restoration efforts. Judging by RMZ rule compliance rates reported in the FPHCP, the goals set forth in this section may be difficult to accomplish without adequate enforcement. Funding deficiencies could also jeopardize the ability to carry out further research into the effect current policies might have in the future.

Another possible complication in managing future restoration efforts in the TCF is the threat of a changing climate. Climate change has the potential to change precipitation patterns and temperature ranges, which could exacerbate problems such as drought, or alter patterns of infestations of insects. Uncertainty about what changes might occur, the magnitude of changes, and the implications of those changes, calls into question the potential level of success for future management strategies in the forest.
