**Decisions:**

**FWEP TWIG**

- ◆ **\*Forested Wetlands Effectives Project Chronosequence Study Plan – approval to go to ISPR**

## **RSAG**

- ◆ **\*Extensive Vegetation Remote Sensing** – *approval of scoping document and findings report*

Joe Murray reported that all CMER and RSAG reviewers have approved all the changes.
