The Bank shall not be liable to inquire whether there has been performance by [the] Assignor or notice has been given Assignor or to see to the application of any monies paid on the instruction of the State, and in such matters the Bank may rely upon the instruction of the State executed over the signature of the person, or his designee, appearing under the Acceptance below without need to verify the authority of such person. Nothing herein shall prevent the State from designating a person authorized to act for it in another lawful manner.
