DNR manages more than 5.6 million acres of state-owned forest, range, commercial, agricultural, conservation and aquatic lands. More than half of these lands are held in trust and produce income to support public schools, universities and other state institutions. Lands managed by DNR provide other public benefits as well, such as outdoor recreation, native fish and wildlife habitat and clean and abundant water. Along with these other roles, the department regulates surface mining reclamation and forest debris burning, administers the state Forest Practices rules on private and state-owned forestlands, and provides wildfire protection for 12.7 million acres of tribal, private and state-owned forests.

The person in this internship position has the opportunity to:

- Coordinate SEPA analysis and public review process for current set of proposed Aquatic Reserves in the summer of 2010.
- Work with the SEPA center to identify the appropriate documents and steps to complete and distribute for public review.
- Work with communications staff to develop press releases and other outreach materials for the SEPA analysis and public review process.
- Lead in setting up the public open houses to be conducted as part of the SEPA analysis and public review process; to include securing appropriate meeting space, working with program staff to develop posters, handouts, and presentation materials, coordinating with partner agencies and entities to provide a presence at the public meetings.
- Complete the SEPA analysis and review process by compiling and summarizing all comments and developing the final determination documents.
