I. Opening, Roll Call

II. Approval of Minutes

Chair Berndt called for approval of the minutes for the June 28, 2017 council. Committee member Pfeiffer-Hoyt moved to approve draft minutes, Committee member DeTro seconded the motion. The motion carried with Aye's.

III. Old Business

a. Forest Health Resiliency Update Mr. Torgerson informed the committee on the progress on the draft strategic plan for forest health and establishment of a Forest Health Advisory Committee. He shared that until approval of the capital budget by the legislature, forest health treatments are delayed. Discussion followed on acres treated and removal of industry timberland owner's property from treatable acres as well as any other managed timber property.

b. Rangeland Protection Association Update – Committee member Hemmer provided an update on the progress on establishing a Rangeland Protection Association. He will meet with BLM. on September 8 and has been reaching out to senators and representatives to invite them to the meeting. He has also gathered information in order to move this forward. Discussion followed on authorities and reimbursement in regards to fighting wildfire.

Committee member DeTro commented on the progress and success of the WFAC achieving goals and seeing that be implemented on the ground.

Committee member Pfeiffer-Hoyt looks forward to hearing proposed solutions and options Mr. Hemmer brings back to the committee.
