Council Purpose and Duty


(Articles of Association, Article II, Section 1)

- C. Promote public awareness and education of community and urban forestry issues.
- D. Provide leadership on community and urban forestry issues.
- E. Provide information for people in the field of, and with an interest in community and urban forestry.
- F. Cultivate cooperation among all sectors involved in community and urban forestry.
- G. Advise the Legislature and the people of the State of Washington on the best ways to preserve, protect, expand, and improve Washington's community and urban forests.
- H. Promote and enhance the implementation of the Urban and Community Forestry Program's strategic plan.

Directions to Natural Resources Building & parking, 1111 Washington Street SE, Olympia, Washington

From Interstate 5: Take State Capitol exit (105), (stay left to follow State Capitol/City Center signs – Exit 105A). The exit puts you on 14th Avenue (stay left at the fork when exiting from I-5 Northbound). Take the second exit of the round-about to go straight through the tunnel. At the stop light, turn right on Capitol Way. Then turn right at the first light onto 11th Avenue. About half way down the boulevard, you will see signs into Visitor Parking; this is the Natural Resources Building parking lot.
