- D. Provide leadership on community and urban forestry issues.
- E. Provide information for people in the field of, and with an interest in community and urban forestry.
- F. Cultivate cooperation among all sectors involved in community and urban forestry.
- G. Advise the Legislature and the people of the State of Washington on the best ways to preserve, protect, expand, and improve Washington's community and urban forests.
- H. Promote and enhance the implementation of the Urban and Community Forestry Program's strategic plan.

Below are driving directions to the Washington State Department of Social and Health Services Headquarters **FROM THE NORTH** 

Take I-5 Exit 105A. Follow "State Capitol" lane, which parallels the freeway for a 1/4 mile. Go straight through the round-a-bout and through the tunnel. At the stop light, turn right onto Capitol Way. Follow Capitol Way to 11th Ave., then turn right onto 11th Ave. Go two blocks and turn right into the Level P2 parking garage entrance. Once in the garage, turn right and go to level P1. Follow the signs to OB-2.

### FROM THE SOUTH

Take I-5 Exit 105. Keep to the left, following "Capitol Campus and Visitor Parking" lane. Go straight through the round-a-bout and through the tunnel. At the stop light, turn right onto Capitol Way. Follow Capitol Way to 11th Ave., then turn right onto 11th Ave. Go two blocks and turn right into the Level P2 parking garage entrance. Once in the garage, turn right and go to level P1. Follow the signs to OB-2
